General clarifications on instruments for evaluation:

Exam – objetive test: A questionnaire of the type assay will be conducted in Moodle, where students are to answer questions by introducing text in the available space and/or draw diagrams or maps that will be attached to the reply.

For this evaluation method the official calls will be maintained (first and second ordinary).

Problem-solving: During the semester a series of weekly problem sets are performed, which are to be uploaded in the platform Moodle. As an evaluation tool, the problem-solving class by videoconference is used, where each problem is solved by a student. This is part of the continuous evaluation.



Oral seminar presentation. Groups of two to three students prepare a seminar of 15 minutes in powerpoint format on a scientific article. As an evaluation tool, the presentation by videoconference is used. This is part of the continuous evaluation.

Oral presentation of real and/or simulated tasks. Groups of two to three students prepare a presentation of 10 minutes in powerpoint format on an experimental design. As an evaluation tool, the presentation by videoconference is used. This is part of the continuous evaluation.

The final grade of the course is calculated according to the following formula:

Final grade = 0.50·grade examen final + 0,15·grade Proble-solving + 0,20·grade Seminar + 0,15 grade real and/or simulated tasks.

According to the agreement made by the "Consejo de Gobierno" of UCO aprproved on 14th of Abril 2020, no minimal grade will be required in any of the evaluation methods in order to pass the course.

GRADE OF NOT PRESENTED.

The grade of "Not presented" will correspond to the student who has not taken part in a number of evaluable activities whose weights on the final grade amount to more than 50% (Art. 80.4 of the Regulations for the Academic Regime of Degree Studies).

For the student who has participated in assessment activities other than the final exam whose accumulated weight on the final grade exceeds 50% and has not attended the final exam of the subject, the teacher will record "Not presented" in the provisional publication of the ratings.

If during the review process, the student does not express his disagreement with that grade, it will be consolidated into the final grade for the course. Otherwise, you must notify the teacher and the final grade would be the weighted sum of the scores achieved in all the assessment methods to which you have attended according to the criteria established in this addendum.
